With nearly a dozen states implementing new PFAS laws and regulations in 2023, and more slated to go into effect this year and next, plus several significant actions already taken by EPA this year, PFAS regulations and the potential liability risks they pose to businesses are a top-of-mind concern for EHS&S professionals.
